Focus on 4 things – Design, organization, promotion, economic restructuring.

Suggestion by attendees – Need to have a concept. Define character within the streetscape design. "Place making"

e.g. Sign toppers, variations in lighting.

Promote what we have. Shop Local. Vote with your dollars. Reach out to people that you think are compatible w/ the area.
